

# PRIVACY POLICY

Rent a Hotel and Spa, a brand of Fast Payments LLC. is committed to maintain security and confidentiality of the personal information gathered and used on the [www.rentahotelandspa.com](http://www.rentahotelandspa.com) website (“hereinafter the Website”). This Privacy Statement covers Rent a Hotel and Spa. This privacy policy sets out how Rent a Hotel and Spa uses and protects any information that you give us when you use this website. Should we ask you to provide certain information by which you can be identified when using this website, then you can be assured that it will only be used in accordance with this privacy statement.

## WHAT WE COLLECT

You may opt in or opt out of our sharing of your personal information with third parties for marketing purposes by following the directions in the “Right to Opt In and Opt Out” section below. This Website is intended for users who are located in the United States of America. This Privacy Policy shall be interpreted under the laws of the United States. Advertisements displayed to you on this Website and other websites may be customized to your interests and preferences, based on your Personal Information and Website Usage Information, which may be obtained from you on this Website or from other sources. This website helps their customers to collect the payments for some hotel reservations. Every customer or user uses this website at their own risk. Using this platform you agree and confirm the read about this Privacy Policy and also about the Terms and Conditions. Fast Payments LLC does not respond about the responsibility to every user.

## PURPOSE

The privacy of your information is important to us. We may collect Personal Information from and about you, and we may collect certain information from your computer about you and your visits to this Website. “Personal Information” includes, for example, your name; home and/or business address; email address; telephone, wireless and/or fax number; reservation and hotel stay information; information from your driver’s license or state or federal ID card, passport image; photo; date of birth; short message service or text message address or other wireless device address; instant messaging address; credit card and other payment information; demographic information; and/or other information that may identify you as an individual or allow online or offline contact with you as an individual.

## USER PROVIDED INFORMATION

We may collect Personal Information from users of our Website, for example, through such users’ activities, transactions, and completion of online forms on our Website. Such information is also collected, for example, when users register or subscribe for accounts or features on our Website; make online purchases; enter sweepstakes and contests; complete surveys; contribute to a chat room, bulletin board, list serve, blog, wiki, or other open forum that we may make available on our Website; submit a comment or question to us using a “contact us” or similar feature on our Website; send us an email; or in any other way submit Personal Information to us via our Website. You may be able to send information about us to your friends and family members through our Website by clicking on an “Email to Friend” or

similar button on our Website or in an email that we have sent you. In some of these cases (unless you simply forward our email on your own), you may provide the name and email address of your friend or family member to us. Such information will be treated in accordance with this Privacy Policy and applicable law.

## COOKIES

We may use “cookies” to keep, and sometimes track, information about you. Cookies are small data files that are sent to your browser or related software from a Web server and stored on your computer’s hard drive. Cookies track where you travel on our Website and on the Web, and what you look at and purchase. They may store the information in your shopping cart, and/or your username and/or password, and they may be used to pre-populate your contact information into online forms on our Website. A cookie may enable us to relate your use of our Website to other information about you, including your Personal Information. All of these purposes serve to improve and personalize your experience on our Website. Most Web browsers can be set to inform you when a cookie has been sent to you and provide you with the opportunity to refuse that cookie. Additionally, if you have a Flash or other media player installed on your computer, your media player may be able to be set to reject or delete cookies known as “local shared objects”. However, refusing a cookie may, in some cases, preclude you from using, or negatively impact the display or function of, the Website or certain areas or features of the Website. ## IP ADDRESS AND CLICKSTREAM DATA

Our server automatically collects data about your Internet address when you visit us. This information, known as an Internet protocol address, or IP address, is a number that is automatically assigned to your computer by your Internet service provider whenever you are on the Internet. Our server may also record the Web page from which you linked to this Website (e.g., another website or a search engine); the pages you visit on this Website; the website you visit after this Website; the ads you see and/or click on; other information about the type of Web browser, computer, platform, related software, and settings you are using; any search terms you have entered on this Website or a referral site; and other Web usage activity and data logged by our Web servers. ### SERVICE PROVIDERS

We may use third-party partners to help operate our Website and deliver our products and services, and may share your information with our service providers and other third parties that provide products or services for or through this Website or for our business (such as website or database hosting companies, address list hosting companies, email service providers, analytics companies, distribution companies, fulfillment companies, and other similar service providers that use such information on our behalf).

### WEBSITE USAGE AND OTHER NON-PERSONALLY IDENTIFIABLE INFO

We may disclose Website Usage Information and other non-personally identifiable information regarding our users and user behavior as a measure of interest in, and use of, our Website, our hotel, and emails to third parties, including, for example, aggregate data, such as overall patterns or demographic reports that do not describe or identify any individual user.

### LEGAL DISCLOSURES

We may disclose user information to government authorities, and to other third parties when compelled to do so by government authorities, at our discretion, or otherwise as required or permitted by law, including but not limited to in response to court orders and subpoenas. We also may disclose user information when we have reason to believe that someone is causing injury to or interference with our rights or property, other users of the Website, or anyone else that could be harmed by such activities.

### BUSINESS TRANSFER

In the event that Fast Payments LLC or substantially all of its assets are acquired by one or more third parties as a result of an acquisition, merger, sale, reorganization, consolidation or liquidation, Personal Information may be one of the transferred assets.
